

CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: —

- The promoter shall submit the copy of license renewal within 3 months from the date of grant of registration certificate;
- (ii) The promoter shall enter into an agreement for sale with the allottees as prescribed by the Government;
